Abstract: Times New Roman 9 font, the justified text, single line space, space after the line 6 pt. The summary contains description of the chapter (maximum 15 rulers).

X.Y. Main points (Times New Roman 12 font, bold, small letters, text to the left, space after the line 6 font, without the dot)

The text of the chapter is written in the editor Word, using exclusively Times New Roman 11 font, spaces between the lines exactly 14 point, and accepting margins for the A4 format appropriately: upper and bottom - 6.5 cm, left - 5 cm, right - 4.5 cm. The text is justified, indenting of the paragraph 0.63 cm. Words dividing is committed. Size of the chapter takes away at most **10** or **12** pages.

Patterns Times New Roman 10 font, centered, variables with italics, on the right side – number of the pattern (X.Y). The editor of equations is exclusively used at writing patterns.

Quoting of literature – the round brackets, the first letter of the name, the dot, the surname, space of the one sign, the year of the edition, the round brackets, e.g. (KOWALSKI J. 2007). In the case of several repeated appearing of the same surname in the same year, the small letter of the alphabet (a,b,c,...) is being written, e.g. (KOWALSKI J. 2003a), (KOWALSKI J. 2003b) the surname is written as small capitals.

Tables. Tables are centered and put on the page, where the first note about it is written (it also concerns figures). Table names are above the table, without the dot after the name, bold 10 font italic.

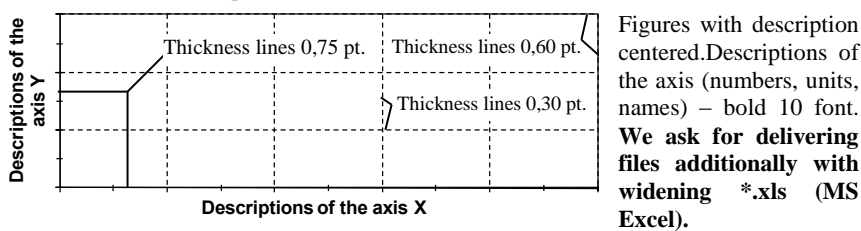

Figures. Graphs, schemes and photographs are treated as figures. The name of figures are put under the figures – italic, bold 10 font. Black-and-white, contrasting photos, the resolution at least 600 dpi. Line of the grid have to be intermittent (fourth type of line in excel) thickness 0,30 pt.

the alphabetical and chronological list are compulsory. List of bibliography – font Times New Roman 10 pt.

Books. KOWALSKI J. 2001 (the surname is written as small capitals, Time New Roman 10 font). *Title in italics*. Publishing company. Place of publishing. The dot.

Monographies. NOWAK A. 2009 (the surname is written as small capitals, Time New Roman 10 font). *Title of the chapter in italics*. The chapter number. In: *Title of monography in italics*. The first letter of the name. The surname - in the round brackets, e.g. (editing and scientific elaboration by KOWALSKI J.). The name of the publisher. The place of publishing. The dot.

JOURNAL. KOWALSKI Z. 2008 (the surname is written as small capitals, Time New Roman 10 font). *Title of the article*. Name of the magazine is in quotation marks. The number/numbers characterize quoted number (without the abridgement No.) The dot.

X.Y. X – the number of the chapter, sent by organizers, Y – the next point of the chapter, pattern, table, figure – sent by author.
